All water meters are installed.

Creekview Lot #4 foundation quote- tabled. Creekview Lot #4 House moving quote- tabled. Creekview Lot #4 Wire Moving quote from REC was reviewed.

The junk items complaint was determined to be valid by the nuisance committee. A certified letter will be issued providing 10 days to abate or respond.

Resolution No. 23-27 Complaint Policy was updated to remove the Public Works Superintendent as a member of the nuisance committee and add a 2nd council person appointed by the Mayor in addition to removing the requirement for the public works department to take additional photos. Resolution No. 23-27 was introduced by Buckner, with a second by Sprague. Roll Call: Buckner-Aye, Sprague-Aye, Griebel- Aye. Mayor Goettsch signed the resolution.

Part-Time employee Performance Review was not introduced in closed session.

Motion by Sprague, second by Griebel to authorize an end of year bonus to W. Burgos in the amount of \$275.00. Ayes; All.

Motion by Buckner, second by Griebel to authorize an end of year bonus to M. Lacey in the amount of \$1,500.00. Ayes; All.

Motion by Sprague, second by Buckner to authorize an end of year bonus to M. Conner in the amount of \$750.00. Ayes; All.

Resolution No. 23-28 Setting Wages provides a \$1.50 raise to W. Burgos sets the wage at \$11.50 per hour effective Nov 6th 2023 through June 30th 2024.

Resolution No. 23-28 was introduced by Griebel with a second by Buckner. Roll Call: Sprague-Aye, Buckner- Aye, Griebel- Aye. Mayor Goettsch signed the resolution.

The part time/seasonal employee hours will be up to 20 hrs weekly however if the need arises the hours may go up to 30 hrs per week with a maximum of 389 hours per quarter.

The Annexation will be put on hold to allow time for all interested parties to review the options.

Motion by Sprague, second by Griebel to request the City Attorney file a petition for the title to abandoned property at 104 Railroad Street Parcel ID # 4200920000 citing no action steps taken by the property owner to abate the property as detailed in the letter sent and increasing hazards at the property. Ayes; All.

Motion by Griebel second by Sprague to approve Resolution No. 23-29 FY23 AFR. Roll Call: Sprague- Aye, Griebel- Aye, Buckner- Aye. Mayor Goettsch signed the resolution.

Reports: Mayor Goettsch reported progress on 193 2nd street and thanked the Public Works Department for getting the water meters completed, and handling the water main break in a timely manner. The City was awarded a grant from Theisens in the amount of \$1,100.00 for the fitness center. Public Works Superintendent Lacey reported the dumpster filled up quickly and will be getting a second dumpster to continue to allow citizens to utilize them for clean up. The library door is installed. Lacey plans to be on vacation Nov 13th through Nov 17th. Thank you to the part time employee for helping with the water meters and fitness center.

Motion by Buckner, second by Sprague to adjourn at 9:00 p.m. Ayes; All.
