Calamus City Council Proceedings August 3, 2015

Mayor Steines called the regular meeting of the Calamus City Council to order at 6:05 p.m. with council members Kalfas, Boedeker, Haack and Dieckmann present. Smith was absent. Also present were city employees Duane Levien and Laurie Ganzer.

- 3. Clean up at 101 Railroad Street The Clerk is trying to find out who now owns the property
- 4. Railroad track repairs UP representative was contacted and asked to write a letter stating that the City can cover the old spur at the City's expense. Letter has not arrived yet.
- 5. A reminder was given to all that the September council meeting will be held on September 1st due to the Labor Day holiday on the regular meeting night.

A motion to approve the application for a **plan and design loan through SRF for the WWTF** was made by Kalfas with a second by Haack. All ayes.

A motion to approve **resolution 2016-01** which is for the approval of the 2015 Annual Streets financial report was made by Boedeker with a second by Haack. All ayes.

Reports:

- 1. Levien noted that recycling needs to be in bins or totes to be picked up.
- 2. The Library Board submitted an annual financial report.
- 3. Levien noted that there was approximately \$23,000.00 in damage to the City property during the recent hail storm. He and the adjuster are still working on the claim.
- 4. Street repair work is not complete. LL Pelling will be back in August some time to complete the work. It was noted that Ganzer should try to obtain the permission from the railroad to cover the spur soon so the work could be done when the streets are finished.
- 5. Levien noted there was a water main break last week.
- 6. Kalfas inquired about removing the walnut trees in the park because they are so messy. The trees will not be removed as it will remove all shade from the park.
- 7. A building permit for a storage shed that was issued approximate 3 years ago will be renewed. The \$10.00 fee will be paid again to make the permit active.
- 8. Rock in front of Millers was discussed but no determination was made.
