Derrick Cline was present to discuss plans for a future **senior housing duplex**.

The Council asked that the **Methodist Church** angle park in the boulevard without removing the grass.

A motion to approve the bid from Electrical engineers for the preventative maintenance of the generators at the bronze level was made by Kalfas with as second by Boedeker. All ayes.

The **Clinton County Sheriff's Office** spent 70.02 hours in the city of Calamus from February 26, 2016 through March 25, 2016 while on patrol they handled 1 incident and answered 8 calls.
