Calamus City Council Proceedings April 2, 2018

Mayor Leibold called the regular meeting of the Calamus City Council to order at 7:00 p.m. with council members Dieckmann, Minor, Buckner, Lacey and Reed present. Also present were city employees Laurie Ganzer and Duane Levien.

Park Board – Lacey reported that Kelly Olson, Dallas McMahon and Heather Grau will be an informal board for the park. They will attend meetings only when changes or upgrades are being requested.

A motion to approve the 2nd reading of **Ordinance 18-12** which is for the utility rate increase was made by Lacey with a second by Buckner. Ayes – Minor, Dieckmann, Buckner and Lacey. Nays – Reed.

A motion to approve the **street repair bid** with LL Pelling for \$20,725.75 was made by Lacey with a second by Buckner.

Sewer Plant warranty work update – Jetco may put transducers in. Seeding needs to be done soon. Miller will core out Corvette Court and Impala Drive before Pelling arrives to do streets.

Reports – Ganzer reported that all dumpsters are being billed for and several shut offs were done last month. Several more people will be sent letters for shut offs in April.

Levien reported that the truck needed wheel bearings and 2 tires.

A water main break today will have the city under a boil order for a few days.
