A motion to approve the resolution approving the **plat of Syslo 1**st **addition** was made by Buckner with a second by Reed. All ayes.

As previously voted on cemetery plots will be raised to 250.00 per plot beginning January 1, 2019.

A motion to place a copy of the **City Council minutes at the Calamus Public Library** within 15 days of the close of the meeting was made by Dieckmann with a second by Buckner. All ayes.

Street bids for RCTP grant application – Dieckmann has met wth LL Pelling. The id estimate should be ready for December meeting.

Park maintenance – Reed reported the rock wall has loose sections & stones. Levien will repair.

Generator service quote was tabled.
