A motion to approve Resolution 2019 - 16 which is for the approval of the 2020 Budget was made by Reed with a second by Dieckmann. All aves.

A motion to approve Resolution 2019 - 17 authorizing and approving an amended Loan and Disbursement Agreement and providing for the issuance and securing the payment of \$1,894,810.96 Sewer Revenue Improvement and Refunding Bonds, Series 2019" was made by Reed with a second by Buckner. All ayes.

A motion to approve the contract with the Clinton County Sheriff's Office in the amount of \$1,037.20 per month was made by Buckner with a second by Reed. All ayes.

A motion to raise the recycling .50 per month was made by Dieckmann with a second by Reed. All ayes.

A motion to approve the building permit for 201 Spring St was made by Reed with a second by Goettsch. Ayes - Goettsch, Dieckmann, Reed. Abstain - Buckner.

A motion to offer Brad Derry Ford in Maguoketa no more than \$39,000.00 for a Ford F350 single cab 4X4 with snow blade with a loan from park savings to be paid back over time was made by Goettsch with a second by Buckner, Ayes – Reed, Goettsch and Buckner, Nays – Dieckmann,

Website review – Goettsch reviewed the website set up he & F & B have worked on.

Reports - RTCP grant for streets will be submitted in March. Lacey is signing up for certification classes. House numbers need to be on the house per city ordinance. Houses without numbers will be notified. If numbers are not placed then the City will number the home and bill the owner for time and materials.
