

**Calamus City Council Proceedings
March 1, 2021**

A motion to approve resolution 2021 – 11 which is for applying for the 2022 RCTP grant was made by Buckner with a second by Goettsch. All ayes.

A motion to approve painting a mural on the north side of the City Hall building between the window and the man door was made by Goettsch with a second by Sprague. All ayes.
