Motion by Leibold second by Buckner to issue a written order to remove a vicious dog to the owner of the dog listed in the vicious dog complaint. Order to be served by the Sheriff's office. Ayes; All.

A proposal for a Bakery and Trucking Company Office were presented. Motion by Sprague second by Buckner to add the Business Catalyst Space 193 2nd street business presentations to May 21st, 2024 at 6pm for further review. Ayes; All.

Motion by Buckner second by Sprague to issue a letter and citation to 114 4th Street for failure to abate a nuisance or request an appeal. Ayes: All.

Motion by Leibold second by Buckner to issue a citation to 600 Davenport Street with a letter explaining the option to appeal at the City Council meeting on June 3rd, 2024 if the nuisance items/dangerous building is not abated within the ten day deadline stated in the abatement letter. Ayes: All.

Resolution No. 24-13 Junior Achievement Proclamation was introduced by Leibold with a second by Sprague. Roll Call: Sprague- Aye, Leibold- Aye, Buckner- Aye, Reed (absent during this time). Mayor Goettsch signed the resolution.

Motion by Buckner second by Leibold to open the public hearing on Fy24 Budget Amendment # 1 at 7:27 p.m. No public comments were received. Motion by Leibold, second by Buckner to close the public hearing at 7:28 p.m.

Resolution No. 24-14 Adopting FY24 Budget Amendment #1 was introduced by Leibold with a second by Sprague. Roll Call: Sprague- Aye, Leibold- Aye, Buckner- Aye, Reed -Aye. Mayor Goettsch signed the resolution

There was public discussion on the offer on Lot 2 of Rose Hill Addition. Some public comments asked the Council not to sell it based on a prior verbal agreement for it to remain for cemetery use when the city purchased the lot. Mayor Goettsch and Attorney Cobie explained the City is legally allowed to sell it and that there was no record of a covenant or restriction placed on the deed at the time of the sale and if there had been, enough time has passed that would still allow the city to sell the lot. A public concern was if there would be enough cemetery plots available for people in the future. Mayor Goettsch provided data which supported many years worth of cemetery plots available based on the average burials per year and the plots available. Additional comments were received in favor and against selling the lot.

Motion by Leibold, second by Buckner to set a special meeting on May 21st at 6 p.m. for Rose Hill Lot 2 Offer and additional city matters. Ayes; All.

Motion by Leibold second by Buckner to table Logan Goettsch's request for fertilizer and land rent reimbursement to May 21st, 2024 pending the sale of Lot 2 Rose Hill Addition. Ayes; All.

Motion by Reed second by Buckner to table discussion on Lot 1 split at Rose Hill Addition east and west pending whether or not Lot 2 is sold. Ayes; All.

Resolution No. 24-16 CCDA Grant Funds Committed to the Calamus Historical SOciety PRoject was introduced by Leibold with a second by Reed. Roll Call: Sprague- Aye, Leibold- Aye, Buckner- Aye, Reed (absent during this time). Mayor Goettsch signed the resolution.

Information was presented regarding the possibility of a voluntary annexation into city limits for Austin Forett's parcel ID 4003230000 & 4003221000. This will be added to the June agenda.

104 Railroad Street discussion on tearing down the property. Resolution to set a public hearing on May 21st agenda with covenant and notice of intent to dispose of the property to be added to May 21st, 2024 agenda.

Motion by Leibold second by Buckner to post to accept quotes to clean the City Hall and Fitness Center with a max amount of \$200.00 per month for weekly cleanings to start in August 2024. Add to the June agenda. Ayes; All.

Motion by Leibold second by Buckner to approve the FY25 street work bid by Manatts for a total of \$25,493.20. Ayes; All.

Motion by Buckner, second by Reed to adjourn at 8:48 p.m. Ayes; All.
